STATUTES UNDER WHICH SERVICE IS RECORDED

CANADIAN CRIMINAL CODE

s.122 (Breach of trust by public officer) — Every public officer named herein who received a demand and refused to act is in breach of trust. Maximum penalty: 5 years.

s.139 (Obstruction of justice) — Every justice system participant named herein who received a mandamus and refused to perform duty is obstructing. Maximum penalty: 10 years.

s.264 (Criminal harassment) — Coordinated refusal across WPS, RCMP, and Crown has crossed the threshold. Maximum penalty: 10 years.

s.380(1)(a) (Fraud over \$5,000) — \$707,000 paid on a forged will by Sun Life Financial. Maximum penalty: 14 years.

JUDICIAL COUNCIL ACTS

Judicial Council Act, R.S.C. 1985, c. J-1, s.5(2) — Removal of a federally-appointed judge. CJC File 26-0430 is open 89+ days.

Provincial Judges Act, R.S.O. 1990, c. P.32, s.51(3) — Removal of a provincially-appointed judge. SCJ Windsor habeas in 127+ day default.

CANADIAN CHARTER OF RIGHTS AND FREEDOMS

s.7 — Deprivation of liberty without fundamental justice. The 127+ day delay on Habeas Corpus #1 (SCJ Windsor) is itself a s.7 breach by the duty-warden.

INTERNATIONAL TREATIES

Palermo Convention (2000), Art. 7, 9, 23 — Republic of Italy in default since the 2007 fabricated consular record. Canada in default since 2005 Tampa FBI warrant and 2016 Raffi Ceylan murder cover-up.

Vienna Convention on Consular Relations (1969), Art. 36 — Italy has refused 19 years to acknowledge the 2007 fabrication.

Rome Statute, Art. 19 — Referral obligation when national proceedings are compromised. Italy and Canada have concurrent obligations; both are in default.

CODICE PENALE (ITALY)

art. 328 (Rifiuto di atti d'ufficio) — Maximum penalty: 1 year imprisonment or fine.

art. 361, 362 (Omissione di atti d'ufficio) — Maximum penalty: 1 year imprisonment.
